#### Safe Operation of Account

The Client assumes full responsibility and will ensure safe custody of all print and electronic correspondence issued to/or by Lotus regarding the account. The Client hereby indemnifies Lotus against any loss, damage or liability resulting from its non-compliance with the above.

#### Variation

The Client agrees that Lotus in its sole discretion may at any time suspend or vary the terms and conditions of the operation of the account. ### Law & Dispute Resolution

These terms and conditions shall be governed in accordance with the laws of the Federal Republic of Nigeria. If Parties are unable to settle any dispute arising out of or in connection with this Agreement within 5 (five) days of the date on which a dispute arose, either Party may refer the dispute to arbitration. Arbitral proceedings shall be presided over by a single arbitrator appointed by the Lagos Multi-Door Courthouse. The arbitration shall take place in Lagos, Nigeria.

### **Know Your Customer**

The Client understands and agrees that Lotus is not obligated to open an account where the Client has not provided complete KYC documentation.
